

Holt Physics Chapter 16 Coulomb's Law Activity Sheet

Coulomb's law states that the electric force, $F_{electric}$, between two charged particles that have charges q_1 and q_2 and are separated by distance r is given by the following equation:

$$F_{electric} = k_C \left(\frac{q_1 q_2}{r^2} \right)$$

On the graphing calculator, this equation has been entered into Y_1 as follows:

$$Y_1 = 8.99E9(AB/X^2)$$

In the graphing calculator program ELF, you will enter the charges and observe a graph of electric force versus distance. By analyzing the graphs for different sets of charges (positive with positive, negative with negative, and positive with negative), you will gain a better understanding of Coulomb's law and how charge and distance affect electric force.

Download the ELF program to your TI-83/84 calculator. Press **PRGM**, then scroll down to ELF by pressing **▾**. Press **ENTER** twice to start the program. Enter the value for the charges (see below). The calculator will produce a graph of electric force vs. distance. Use **TRACE** to determine the force at selected distances (see below). Press **2nd****[QUIT]** to stop viewing the graph. Press **ENTER** to restart the program.
