May include the investigation of physical causes of accidents and other sources of claims and litigation, preparation of engineering reports, testimony in hearings and trials in administrative or judicial proceedings, and the provision of advisory opinions to assist in the resolution of disputes that affect life or property. *Milton F. The Forensic Engineer is a professional engineer who deals with engineering associated with legal issues. Activities associated with forensic engineering include determining the physical or technical causes of accidents or failures, preparing reports, and presenting testimonies or advice and opinions that assist in the resolution of related disputes.
