Prior Knowledge Questions

- Label one of the **skulls** below as human and the other as a chimpanzee skull.



Human



Chimpanzee

- What features did you use to identify which skull was human and which was chimpanzee?

The shape of the **cranial cavity** and jaw, as well as the **front of the mouth**. Also because of the **shape of the teeth** and placement of **tooth sockets**, and **jaw line**.

In 1924, a fossilized skull that looked very similar to a chimp skull was discovered. But the skull most definitely did not belong to a chimp. The location of the **foramen magnum**—a hole in the skull where the spinal cord exits—indicated that the individual was **upright**, or walked on two legs. This fossil was some of the earliest evidence of human evolution.

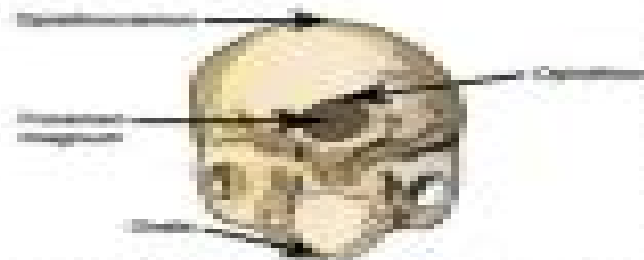


- Examine the **front** view of the **homo sapiens** (modern human) skull. Examine the same view of the **Pan troglodytes** (chimp) skull.

How do the skulls compare?

The chimp skull is more elongated. Also the teeth are spaced very differently.

Now, examine the **bottom** view of the two skulls. How do they compare?



Interpretation: Skulls, even from the same species, use **many** a wide variety of shapes and sizes. To compare skulls, scientists use measurements of certain features to calculate indices. An **index** is a ratio of one measurement to another.

An important index for measuring human skulls is the **cephalic index**. This index indicates the position of the foramen magnum in the base of the **skullcase**. The cephalic index can indicate whether a fossilized species was bipedal or not.

Question: How does the location of the foramen magnum indicate if a species was bipedal?

- Measure:** Examine the **bottom** view. To determine the cephalic index for humans and chimps, follow the steps below and complete the table.
