 2. In the general method, the amount being contributed and the corresponding percentage of the total capital interest are used to calculate the value of the business and the percentage of goodwill or gain which previously occurred as an original asset.
3. Partnership income allocation
 - a. At the end of each fiscal period, the respective and relative accounts should be closed and with the resulting income figure being assigned to the individual capital accounts.
 - b. The method of allocating income to the capital accounts should be consistent with the nature of partnership.
