Accounts Payable: The money that a business owes to its creditors. This money is a liability to the business.

Net Worth/ Capital/ Owners Equity: Calculated by assets-liabilities.

Accounting Cycle: The total set of accounting procedures that must be carried out during each fiscal period. Outer Ring: ongoing activities. Inner Ring: yearly activities.

Fundamental Accounting Equation: $A=L+OE$ or $A-L=OE$

Liquidity: The ease with which an asset can be converted into cash.

Financial Position: The status of a business, as reported by the assets, liabilities, and owners equity.

Public Accountant: An accountant who offers services professionally to the general public.

Creditor: Anyone who is owed money by the business.

Debtor: Anyone who owes money to the business.

Auditing: Process of conducting an audit: an examination of the accounting records and internal controls of a business in order to be able to express an opinion about the business financial position and results of operation.

Public Accounting: A profession of the public accountant who offers a variety of accounting services to the general public.

Liquidation: The sale of assets of a business for cash.

Accounting Clerk: An employee who ensures that transactions are properly recorded and that supporting documents are present and correct. Carries out routine calculations and banking transactions.

Accountant: A professional person who develops and maintains the accounting systems, interprets the data and prepares reports; supervises the work of accounting employees and participates in management decisions.
