2.1 The account, the ledger and the journal

- An **account** is the detailed record of all the changes that have occurred in a particular asset, liability or owners' equity during a period
- The **journal** is the chronological record of the transactions
- The **ledger** is the record holding all accounts
- A list of all the ledger accounts, along with their balances, is called a **trial balance**
