Exercise 3-1 (10 minutes)

The estimated total manufacturing overhead cost is computed as follows:

$$Y = \$94,000 + (\$2.00 \text{ per DLH})(20,000 \text{ DLHs})$$

Estimated fixed manufacturing overhead	\$ 94,000
Estimated variable manufacturing overhead: \$2.00 per DLH × 20,000 DLHs	<u>40,000</u>
Estimated total manufacturing overhead cost	<u>\$134,000</u>

The predetermined overhead rate is computed as follows:

Estimated total manufacturing overhead	\$134,000
÷ Estimated total direct labor hours (DLHs).....	<u>20,000 DLHs</u>
= Predetermined overhead rate	<u>\$6.70 per DLH</u>
