6.2 Laws of Energy Flow in the Living World

Energy is freely convertible from one form to another but **energy** can never be created or destroyed.

Systems that convert energy from one form to another are not 100% efficient, thus the amount of useful energy **decreases**.

In nature, as energy freely changes from one form to another, the total amount of energy **decreases because some energy becomes useless**.

In living things, energy conversion is inefficient, with much energy being lost in the form of **heat**

What form of energy do producers use when they set about to generate chemical energy—the energy of C—H and C—O—H bonds. **solar energy**

Thus, a producer organism is called a “producer” because it produces usable **chemical energy**

When your car engine burns the octane in gasoline, in what form does at least 50% of the energy of the octane end up? **heat**
