Rights that protect people from unfair treatment by individuals or government protects against

- ⇒ Employment

### Private Law

Family law ⇒ governs relationships between families (divorces and marriages)

Contract law ⇒ people or companies to purchase or provide goods and services

Tort law ⇒ wrongs and damages that a person/company causes
