 - The collecting, recording, summarizing, and analyzing of financial activities
 - Financial Accounting Standards Board (FASB) - 1973
 - Generally Accepted Accounting Principles (GAAP)
 - Commonly accepted accounting principles, standards and procedures
 - Provide transparency, guidance, ease of analysis, comparison
 - Only a minimum set of standards
 - Two types of accountants:
 - Private Accountant
 - Employed to serve one particular organization
 - Prepare financial statements ("do the books")
 - Developing accounting systems
 - Tax returns
 - Providing financial information for management decision making
 - Certification needed
 - Non-private Accountant
 - Two Types of work
 - Consulting
 - Financial forecasting, determining profitability, risk management, strategy and operations, set up accounting practices, etc.

 - Certification of financial statements and if organization followed laws and regulations
