But if most of the supposed costs of Chapter 11 are in fact exogenous to the Bankruptcy Code, reductions in the cost of Chapter 11 may have only a modest correlation with reductions in the cost of financial distress. This paper thus offers the first look at the intra-debtor distribution of professional fees. I analyze a new sample of almost 4,000 attorney time entries from more than 30 law firms in 27 very large Chapter 11 cases filed between 2001 and 2003 to look at several basic questions regarding the allocation of attorney's fees within Chapter 11 cases. I find that up to 60% of the professionals' fees in a bankruptcy case may be exogenous to Chapter 11. I then develop the broader argument that ex ante costs are virtually irrelevant to current discussions of Chapter 11.
