

WHAT IS A DISSOLUTION?



In chemistry, a **dissolution** or solution is a homogeneous mixture, at a molecular level, of one or more chemical species that do not react with each other, with components present in varying proportions within certain limits.

Every solution or **dissolution** is composed of a dispersed phase called the solute and a dispersing medium known as the solvent. The solvent is also defined as the substance present in greater quantity than the solute in the solution.
