Boiling points are elevated because shells of solvent form around solute particles, reducing the amount of solvent molecules that have sufficient energy to escape the solution; relative to the pure solvent, the amount of energy required to cause vaporization or boiling increases. Solutes disrupt the ordering of the solvent structure, so more kinetic energy must be withdrawn from a solution for it to solidify. This lowers the freezing point of the solution.
