A. WHAT IS THIS LAWSUIT ABOUT?

Plaintiffs Jesse Grady and Desiree Duran filed this lawsuit against People 2.0 Global, LLC and People 2.0 North America, LLC (referred to as the "Defendants"), claiming that the wage statements that Defendants furnished to their California employees do not show the inclusive pay period dates and the name and address of the employer as required by California Labor Code section 226(a). Although Defendants deny any liability or wrongdoing of any kind and believe their practices were legally sufficient, they have entered into this class action settlement, in which you are included as a class action settlement member. Moreover, on November 8, 2017 and January 31, 2018, Defendants revised the form of their wage statements to strictly comply with Labor Code section 226(a). The Court has made no determination about the strengths and weaknesses of the claims or contentions of either Plaintiffs or Defendants.

According to Defendants' records, you are a member of the Class as defined in the accompanying Class Notice, and were issued one or more wage statements from December 4, 2016 through January 31, 2018.

B. INSTRUCTIONS FOR SUBMITTING A CLAIM.
