Inverse square law:

Objects further apart, $F_g \downarrow$

480 ÷ 60 = 8x further apart, so F_g is $8^2 = 64$ x smaller

$$1200 \div 64 = 18.8 \text{ N}$$

3. Two students are on a skateboards and push away from each other. A 48 kg student accelerates away at 2.6 m/s^2 . Find the acceleration of the other student if their mass is 32 kg. Action-reaction forces

$$F_{net} = ma$$

$$F_{net} = 48(2.6)$$

$$F_{net} = 124.8 \text{ N}$$

F_{net} is the same for both students

$$F_{net} = ma$$

$$124.8 = 32a$$

$$a = 3.9 \text{ m/s}^2$$

4. A 42.0 N force is applied to a 6.00 kg block but it only accelerates at 5.50 m/s^2 . Determine both the force and the coefficient of friction.



$$F_{net} = ma$$

$$42 - F_f = 6(5.5)$$

$$42 - F_f = 33$$

$$F_f = 9.0 \text{ N}$$

$$F_f = \mu F_n$$

$$9.0 = \mu(58.8)$$

$$\mu = 0.153$$
