CHAPTER 1.THE MANAGER AND MANAGEMENT ACCOUNTING

Management accounting measures, analyzes, and reports financial and nonfinancial information that helps managers make decisions to fulfill organizational goals. Management accounting need not be GAAP (generally accepted accounting principles) compliant.

- **Managers use management accounting information to:**
 - Develop, communicate and implement strategies
 - Coordinate product design, production, and marketing decisions and evaluate a company's performance

Financial accounting focuses on reporting financial information to external parties such as investors, governmental agencies, banks, and suppliers, **based on GAAP.**

Cost Accounting measures, analyzes and reports financial and nonfinancial information related to the costs of acquiring or using resources in an organization.

Take into account that accounting professionals have the perspective that cost information is part of the information collected in order to make management decisions, which is why there is not a clear cut distinction between the two in this book, and these terms are often used interchangeably.

Strategic decisions and the Management Accountant.

Strategy specifies how an organization matches its own capabilities with the opportunities in the marketplace (cost leadership and product differentiation)

Strategic cost management describes cost management that specifically focuses on strategic issues.

Management accounting information helps managers formulate strategy by answering questions such as the following: (not so important just take a look at this)

- Who are our most important customers and what critical capability do we have to be competitive and deliver value to our customers?
- What is the bargaining power of our customers?
- What is the bargaining power of our suppliers?
- What substitute products exist in the marketplace and how do they differ from our product in terms of features, price, cost and quality?
- Will adequate cash be available to fund the strategy, or will additional funds need to be raised?
