Continuation patterns are price patterns that show a temporary interruption (pause) of an existing trend.

On the other hand, reversal patterns are opposite to continuation patterns. They usually reverse the current price trend, causing a shift from one direction to the opposite direction.

Neutral patterns signal a price move, but the direction is unknown. In the process of the pattern completion, traders realize the pattern's potential and trade the direction with the respective trend.

Special trading patterns appear at both market limits, and have predetermined outcome direction.
