

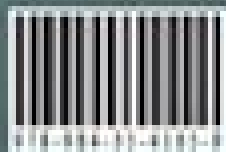
Intellectual Property Law: Text, Cases & Materials

The discussion centres on how an intellectual creation qualifies as an intellectual property, and how its registration and protection can be secured locally and internationally within the administrative and judicial setups. The discussion also focuses on exceptions to intellectual property rules which can help fulfilling the substantive needs of the people in a fast developed country like Bangladesh who will graduate to be developing country within time.

Mohammad Towhidul Islam is currently a Professor of Law in the University of Dhaka. He did his PhD in Intellectual Property Law at Monaghan Law School, Trinity St. He holds LL.M in International Human Rights Law from UCL Law School, London. Earlier he graduated from University of Dhaka for his LLB (Honours) and LL.M. He teaches Law: Intellectual Property Law, International Trade Law, Company Law, and Legal Research. His writing extensively in Intellectual Property Law, International Trade Law, and International Human Rights Law.
