If your concession entitlement is reduced or withdrawn, you must notify the Department of Transport immediately. If you continue to claim concession rates on a vehicle and you are no longer entitled to that concession, the vehicle licence will be deemed invalid. The continued use of the vehicle on any road will be in contravention of the Road Traffic (Vehicles) Act 2012. You may be fined, required to pay additional penalties and your vehicle may not be insured.

VEHICLE LICENCE CONCESSION

The appropriate pensioner concession card and/or letter from the pension provider must be produced for you to be eligible for a concession. Below is a list of the documentation that must be presented when making application for a motor vehicle licence concession. **Veterans' Affairs concessions** - if you are applying for a refund you may be required to provide a letter from Veterans' Affairs confirming the date of grant.

THE MOTOR VEHICLE LICENCE CONCESSION APPLIES TO ONLY ONE OF THE FOLLOWING:

1. a car or bus with an unloaded mass not exceeding 3000 kg;
2. a goods vehicle with an unloaded mass not exceeding 3000 kg;
3. a motor home;
4. a motor cycle; or
5. a moped as defined in the Road Traffic (Authorisation to Drive) Regulations 2008.

100% Concession

To be eligible for a 100% vehicle licence fee concession (exemption) and exemption from vehicle licence duty you must hold one of the following:

- Letter from Veterans' Affairs or Centralink stating you are receiving the maximum rate of pension **and one of the following:**
 - Veterans' Affairs Service Invalid Pension Card; or
 - Centralink Pensioner Card (blind); or
 - Centralink Disability Support Pension Card; or
 - Centralink Pensioner Card (carer).

Or one of the following:

- Letter from Veterans' Affairs certifying the applicant has been assessed at 60 or more impairment points.
- Veterans' Affairs Gold DVA Health Card endorsed TPI.
- Veterans' Affairs Gold DVA Health Card endorsed EDA.

50% Concession

To be eligible for a 50% vehicle licence fee concession you must hold one of the following:

- Centralink Pensioner Concession Card;
- Veterans' Affairs Pensioner Concession Card; or
- WA Seniors Card **and** Commonwealth Seniors Health Card (both cards must be presented).

To be eligible for a 100% concession on your driver's licence you must possess **one** of the following cards:

- Centralink Aged Pensioner Concession Card;
- WA Seniors Card **and** Commonwealth Seniors Health Card (both cards must be presented);
- Veterans' Affairs Pensioner Concession Card (where the holder is receiving a service pension and is of pension age. Please contact the Department of Veterans' Affairs for more information); or
- Veterans' Affairs Gold DVA Health Card endorsed TPI or EDA.

50% Concession

To be eligible for a 50% concession on your driver's licence you must possess **one** of the following cards:

- Any other Centralink Pensioner Concession Card;
- WA Seniors Card; or
- Veterans' Affairs Pensioner Concession Card (where the holder is receiving a service pension and has not yet reached pension age. Please contact the Department of Veterans' Affairs for more information).

Photo Card Concession

The concession on your driver's licence will be applied to your future photo card applications.
